## DISABLED VETERANS REAL ESTATE TAX EXEMPTION



Disabled veterans who are residents of Pennsylvania may be exempt from the payment of all real estate taxes levied upon their principal residence and the land upon which it sits, provided that all eligibility criteria is met.

### Eligibility:

- Must be a resident of Pennsylvania
- Honorable or Under Honorable Conditions Discharge
- Served during established periods of war, as determined by the U.S. Dept. of Veterans Affairs, or other armed conflict
- Must be blind or paraplegic or have sustained the loss of two or more limbs, or to have service-connected disability declared by the U.S. Dept. of Veterans Affairs to be a total or 100% permanent disability
- Dwelling must be owned solely by the veteran, jointly with the veteran's spouse, or as an estate by the entireties
- Veteran must occupy the real estate as his / her principal dwelling
- Veteran must demonstrate a financial need
- Upon the death of a qualified veteran, tax exemption may pass on to the unmarried surviving spouse if financial need can be shown

### Application:

Contact the County Director of Veterans Affairs in the county you reside to apply for this program.

## VETERANS TEMPORARY ASSISTANCE

Provides temporary cash financial assistance to veterans and their dependents who reside in Pennsylvania for the necessities of life (food, shelter, fuel, clothing and medical expenses). If eligible, a veteran or their dependent can qualify for an amount not to exceed \$1,600 in a 12-month period.

### Eligibility:

- Must be a resident of Pennsylvania
- Must demonstrate a financial need
- Must show either an unexpected loss of income or increase in expenses that renders the applicant temporarily unable to provide themselves with the necessities of living
- Must have a discharge of Honorable or Under Honorable Conditions after a period of active duty, other than active duty for training or have a service-connected disability rating as certified by the U.S. Dept. of Veterans Affairs

### Surviving Dependent Eligibility:

- Upon the death of a veteran, his / her unmarried spouse, dependent child, or dependent parent is eligible provided the veteran would have qualified prior to his / her death
- Death Certificate for the veteran must be included with the application
- Must provide marriage certificate for spouse, birth certificate for children, and the veteran's birth certificate for parents

### Application:

Contact the County Director of Veterans Affairs in the county you reside or see an accredited representative of a Veterans Service Organization to apply for this program.

## BLIND VETERANS PENSION

Provides for a pension of \$150 per month.

### Eligibility:

- Served in the military honorably
- Resident of Pennsylvania upon entering the military
- Suffered a service-related injury or incurred a disease which resulted in loss of vision:
  - Visual acuity with the best correcting lens is 3/60
- or*
- 10/200 or equivalent, of less normal vision in the better eye
- Includes circumstances where the widest diameter of the visual field of the better eye has contracted to an angular distance of not greater than 20°

### Application:

Contact the County Director of Veterans Affairs in the county you reside or see an accredited representative of a Veterans Service Organization to apply for this program.

## AMPUTEE AND PARALYZED VETERANS PENSION

Provides for a pension of \$150 per month.

### Eligibility:

- Served in the military honorably
- Resident of Pennsylvania upon entering the military
- Suffered a service-related injury or disease resulting in the loss or loss of use of two or more extremities
- At least 40% disability compensation rating or higher in each limb as determined by the U.S. Dept. of Veterans Affairs

### Application:

Contact the County Director of Veterans Affairs in the county you reside or see an accredited representative of a Veterans Service Organization to apply for this program.

## EDUCATIONAL GRATUITY



The Commonwealth of Pennsylvania provides financial assistance of up to \$500 per term / semester for up to eight semesters to the children of honorably discharged veterans who have service-connected disabilities and served during a period of war or armed conflict or children of veterans who died in service during a period of war or armed conflict.

### **Veteran Eligibility:**

- Died in service during a period of war or armed conflict,  
*or*
- Honorable Discharge
- Served during established war service dates as determined by the U.S. Dept. of Veterans Affairs
- Veteran must have a 100% permanent and total service-connected disability rating by the U.S. Dept. of Veterans Affairs

### **Child Eligibility:**

- Must be between the ages of 16 and 23, living within Pennsylvania five years prior to application and must attend an approved educational institution within the state
- Applicant must demonstrate a financial need

### **Application:**

Contact the County Director of Veterans Affairs in the county you reside or see an accredited representative of a Veterans Service Organization to apply for this program.

## PENNSYLVANIA VETERANS HOMES



Pennsylvania offers its eligible veterans or surviving spouses residency in one of the six extended-care facilities throughout the state. The varying levels of care provided include personal care, skilled nursing care, and memory care.

### Eligibility:

- Honorable Discharge
- Served in the U.S. or PA Armed Forces
- Resident at time of entry or current resident of Pennsylvania

## HONORING OUR VETERANS LICENSE PLATE



You don't need to be a veteran to show your support of veterans by purchasing the "Honoring Our Veterans" license plate. This plate is available for motorcycles, passenger cars and light trucks up to 10,000 pounds. Fifteen dollars from the sale of each license plate goes to the Veterans' Trust Fund. Please refer to Form MV-914 (PDF) for pricing.



The "Honoring Our Women Veterans" registration plate became available on Feb. 21, 2019. Fifteen dollars for every "Honoring Our Women Veterans" registration plate sold will benefit the Veterans' Trust Fund, which will be used for programs and resources that assist women veterans. ## DRIVER'S LICENSE / ID CARD VETERANS DESIGNATION



The Veterans Designation on Pennsylvania driver's licenses and ID cards clearly identifies the bearer as a veteran, who honorably served their nation and commonwealth.

### Application:

To apply for this designation, visit [www.pa.gov/agencies/dmv/resources/military-personnel-veterans](http://www.pa.gov/agencies/dmv/resources/military-personnel-veterans). Initial issuance, renewal or duplicate driver's license of identification card fees apply.

PA VETConnect is an exciting Regional Outreach Program by the Department of Military and Veterans Affairs (DMVA), Bureau of Veterans Outreach. A pathway to a better means of serving Pennsylvania's nearly 700,000 veterans, the objectives of PA VETConnect are simple: determine the needs of veterans and their beneficiaries, find resources that meet those needs, and connect veterans with those resources. Additionally, PA VETConnect will assist service members with reintegration into Pennsylvania communities following their military service.



Through PA VETConnect, veterans and veteran advocates have access to the commonwealth's premier statewide network, PA Navigate ([www.panavigate.org](http://www.panavigate.org)). PA VETConnect staff use this statewide network, and their own internal information and referral database to connect veterans in Pennsylvania with the health and social care services they need.



Regional outreach staff live and work in each of the five regions as our “Boots on the Ground” individuals who provide and coordinate outreach throughout the region, establish and maintain working relationships with community leaders and local / regional organizations, Veteran Service Organizations, local / county / state government agencies, and other community partners to gather information, and to identify resources to facilitate the delivery of services to veterans, service members and their beneficiaries.

## MILITARY FAMILY RELIEF ASSISTANCE PROGRAM (MFRAP)

Provides emergency financial assistance to eligible Pennsylvania service members and their eligible family members, and must have a direct and immediate financial need as a result of circumstances beyond their control.



### Eligibility:

The program applies to Pennsylvania residents who:

- Serve 30 or more consecutive days of active duty with the U.S. Armed Forces or its reserve components
- Serve 30 or more consecutive days of active duty or state active duty in the Pennsylvania Army or Air National Guard
- Are a member in good standing of any reserve component of the U.S. Armed Forces, including the Pennsylvania National Guard, for a period of three years after release from a tour of active duty, authorized under Title 10 or Title 32, U.S. Code (other than active duty for training), of 30 or more consecutive days duration, when the need for assistance is directly related to the member's performance of active duty
- Are a member in good standing of the Pennsylvania National Guard for a period of three years after release from tour of state active duty of 30 or more consecutive days duration, when the need for assistance is directly related to the member's performance of state active duty
- Are a former member of the U.S. Armed Forces of the United States or its reserve components, including the Pennsylvania National Guard for a period of four years after a medical discharge for a medical disability incurred in Line of Duty and the reasons arising to the discharge did not exist prior to the member's military service, and meets the other requirements as shown in the Guidelines, Para 4 v. 1 through 6

## VETERANS REGISTRY

The PA VETERANS REGISTRY— [www.pa.gov/agencies/dmva/pennsylvania-veterans/pennsylvania\\_veterans-registry](http://www.pa.gov/agencies/dmva/pennsylvania-veterans/pennsylvania_veterans-registry)— is an online application that allows veterans, family members and people who work with veterans to connect with DMVA to request information related to the valuable state benefits, programs and services offered. All registrants' information will be shared with other Commonwealth of Pennsylvania agencies in order to facilitate local connections. By connecting with DMVA through the Registry, registrants can also opt-in to receive ongoing communications such as the Together We Serve online publication (most recent issue can also be found at [www.register.dmva.pa.gov](http://www.register.dmva.pa.gov)), breaking news, and other updates.

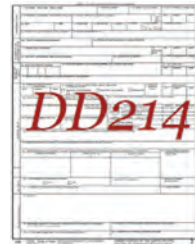
## DD FORM 214 PROGRAM & RECORDS REQUEST PROGRAM

Documents so important as these should be kept in a safe place. We highly recommend that veterans record their discharges / DD Form 214s (DD-214s) with their County Courthouse so they are able to obtain free certified copies for the remainder of their life and so they are available to next of kin upon their death. The DD-214 provides the member and the service with a concise record of a period of service with the Armed Forces at the time of the member's separation, discharge or change in military status. In addition, the form is an authoritative source of information for both governmental agencies and the Armed Forces for purposes of employment, benefit and reenlistment data. If you do not currently have a copy of your Certificate of Release or Discharge, DD-214, now is the time to obtain it before you need it.

## PENNSYLVANIA NATIONAL GUARD RECORDS

Pennsylvania Army and Air National Guard maintain a state file of service after 1985. Information from these state files varies but should include records of enlistment, discharge and other administrative actions. The veteran or next of kin of a deceased veteran can obtain copies of available information by providing a Record Request Form, mailed to:
