## COST OF CARE AT A PENNSYLVANIA VETERANS HOME (PVH)

Residents of a PVH are required to contribute to their Cost of Care based upon ability to pay. Veterans and their spouses are eligible for admission regardless of their net worth. Fees will be based upon monthly available income and excess assets when applicable.

## KEY TERMS

**Per Diem** – The Federal VA’s daily reimbursement rate for each night a veteran stays in a PVH.

**Cost of Care** – The daily cost to care for a veteran, as published in the Pennsylvania Bulletin.

**Maintenance Fee** – A resident’s monthly minimum payment towards the Cost of Care. This payment usually does not pay for the entire cost of care. This fee is based upon the resident’s available income after health insurance and other allowable deductions.

**Estate Recovery Plan** – DMVA’s practice of collecting the unpaid Cost of Care from available assets held in the deceased resident’s estate.

## MONTHLY MAINTENANCE FEES

Here’s how the PVH’s calculate monthly maintenance fees:

- The resident’s income from all sources will be considered in calculating the monthly maintenance fees.
- Certain deductions are allowable, such as medical insurance premiums and spousal allowances.
- Monthly maintenance fees are set upon admission and are recalculated annually. The fees may also be adjusted whenever there are changes in a resident’s financial situation.
- Assets owned by the resident or their spouse over limits set by the Federal VA for pensions will result in the resident paying the full Cost of Care until their assets are under the limit.

## ESTATE RECOVERY PLAN

Acceptance of a monthly maintenance fee based on income will result in the Pennsylvania Department of Military and Veterans Affairs (DMVA) asserting a claim against a resident’s estate:

- DMVA asserts a claim against the estate of a deceased resident for the difference between the full Cost of Care and any funds received during their stay, including Monthly Maintenance Fees, insurance payments, and VA per diem.
- Only the resident’s estate is obligated to pay the claim, not surviving spouses or family members.
- Attorneys from the DMVA work with the representatives of the estate and next of kin to address the claim.
